Sl. No.	GENERAL CONDITIONS - The school is directed to ensure that :		
1.	The total number of section of the school shall be restricted to 24 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.		
2.	Compliance of the points no. 1 to 9 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.		

SI. No.	CONDITIONS FOR COMPLIANCE
1	The total number of sections of the school shall be restricted to 24, of which not more than 1/3rd sections may be used for senior secondary classes and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of >500 ft dimension.
2	The school has constructed a ramp to access the upper floors, but the slope gradient of the same is steep and is not navigable by a wheelchair-bound student/staff. Further, in the compliance, school has stated that, school will install the lift within a period of 2 months. Therefore, the school is directed to dismantle the ramp and install lift to access upper floors with the provision laid in RPWD Act and board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) and maintain the Prominent signage at CWSN toilets (indicating the floor numbers) within 03 months and submit the compliance.
3	The building safety certificate is not in the prescribed format as it neither mentions the building blocks(2) nor the number of floors in each block. The school has submitted NoC for availability of fire safety equipment in the school instead of fire safety certificate which like the building safety certificates should cover all building blocks of the school. The school shall submit revised building safety and fire safety certificates with requisite details within 3 months and submit compliance on SARAS.

4	The school has placed moveable/temporary wooden wedges outside CWSN cubicles in washrooms which are not safe for students. The school shall construct permanent concrete ramps in their place as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.				
5	The library is seen as under sized and under stocked. No separate reading area for teachers is seen. The school shall shift the library to a bigger room with adequate reading space for students and staff and upgrade it as per SoP issued by the Board within 3 months and submit compliance on SARAS.				
6	Failure to submit compliance on the above mentioned points within the prescribed time shall invite financial penalty against the school.				
7	The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance.				
8	The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.				
9	The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time.				

The above is subject to fulfillment of the following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness.

 In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
